In 2003, the Japan Foundation's legal status was changed, making it an independent administrative institution. We are currently carrying out a large-scale reform of this institution - the first since its establishment in 1972. The purpose of the reform is to enable the Foundation's programs to respond more efficiently and effectively to the changing demands of the times while further developing and enriching the Foundation's existing activities.

In JFY2005, the Foundation reaffirmed our commitment to reawakening interest in the diverse cultures of the world through international cultural exchange activities.

Today, the flow of information through the Internet and satellite broadcasts is far-reaching, and the sense of distance between countries narrows every day. People now feel a more personal connection to wars and conflicts overseas, and as a result they are more often emotionally affected by these situations. Solving the various challenges facing us will require that we establish deeper bonds of trust and friendship with people in other countries, and that we share our knowledge and work together to a greater degree than ever before.

The Japan Foundation is committed to becoming a catalyst for and a practitioner of efforts to encourage dialogue and exchange among people from different backgrounds to promote a mutual understanding through culture, an international public good.

The Japan Foundation Center for Global Partnership has a unique mission of tackling new global challenges by enhancing the collaboration between the United States and Japan through intellectual and grassroots exchange. We will continue to carry out CGP's work in a way that makes full use of this dynamic and responds flexibly to the changing world around us and the new challenges it presents.

Message from the Executive Director

The JFY2005 activities of the Japan Foundation Center for Global Partnership (CGP) are described in this report. JFY2005 was a year in which we rethought CGP's activities. In response to the reform of the Japan Foundation as a whole, in July 2005 we dissolved the CGP Advisory Committee of outside experts from Japan and the United States, which had offered valuable advice on program strategies since CGP's inception. We began to prepare a new structure that will allow us to more effectively coordinate the activities of CGP with the activities of the Japan Foundation in the United States. Another new initiative during the past year was a collaborative project with the Maureen and Mike Mansfield Foundation, which yielded synergies that benefited both programs. CGP also launched a new educational effort focused on the Southern part of the United States in order to encourage understanding of Japan in a region that has had limited exchange with Japan in the past.

The US-Japan relationship continued to be positive over the past year, and the leaders of our two countries have developed personally strong ties. Such good relations, however, cannot continue indefinitely without concerted effort. CGP will continue to support collaborative efforts between American and Japanese people to tackle the challenges facing the world. We will strive to serve as a "connector," linking people with diverse values so that they may work together to develop mutual understanding and find solutions to common problems.

I hope that you will offer your continued support of and participation in CGP activities in the years ahead.

Intellectual Exchange Program

CGP's Intellectual Exchange Program supports US-Japan collaborative projects from universities and research institutions that encourage policy-oriented research and dialogue on global issues of common concern. Particular consideration is given to projects that bring together scholars, practitioners, and policymakers from the US and Japan, in addition to their counterparts from other countries. Through these activities, CGP support aims to create new networks and provide opportunities for advancing research and candid discussions that lead to a more informed society. The Program seeks projects focusing on contemporary social issues, including global economic relations, global security, sustainable development, civil society, and health care and aging.

Self-Initiated / Co-sponsored Activities

CGP self-initiates or co-sponsors various activities with other institutions to nurture professionals in the US and Japan involved in playing an active role in the bilateral and global network.

RIPS - CGP Security Studies Fellowship Program for Japanese Researchers

This program offers training opportunities for young Japanese security specialists with a Ph.D. or an equivalent level of professional experience. Over the course of two years, they participate in monthly research seminars and receive research guidance from the Program Directors. [Co-organizer: Research Institute for Peace and Security (RIPS)]



US-Japan Young Political Leaders Program

This program takes a long-term approach to strengthening the foundation for US-Japan relations by facilitating exchange between future political leaders from the United States and Japan. Young politicians, Diet and congressional secretaries, and party staff visit the other country's capital and local cities to exchange opinions on issues that confront both countries. In 2005, program evaluation was conducted to further strengthen its operation. Japanese American Leadership Delegation Program

The goals of this program are to strengthen ties between Japanese American leaders and their counterparts in Japan and to develop ongoing strategies to enhance the role of Japanese Americans in advancing US-Japan relations. In March 2006, 15 Japanese American leaders visited Japan to participate in a CGP-supported public symposium entitled "From Arts to Business: Japanese Americans in the Professional Arena" in Nagoya. Public Symposium : "Non-Traditional Security : The Transformation of Cooperation between the United States and Japan"

CGP and the Maureen and Mike Mansfield Foundation implement the Abe and Mansfield Fellowships, respectively. Together, CGP and the Foundation organized this public symposium, "Non-traditional Security: The Transformation of Cooperation between the United States and Japan" with Japanese Abe Fellows and US Mansfield Fellows from relevant fields. Approximately 120 people participated in the symposium including researchers, officials working in diplomacy and defense, journalists and other representatives of the media, students and members of the general public.



Partnership with US Think Tanks

CGP and the Brookings Institution co-sponsored a research project on Asian security issues by Dr. Yoichi Funabashi (Abe Fellow 1996-97).

US-Japan Innovators Project

Abe Fellowship

The Abe Fellowship supports international multidisciplinary research on topics of pressing global concern with the goal of nurturing a community of researchers interested in playing an active role in a bilateral and global research network centered on these long-range issues. Fellowship proposals focus on research in the social sciences or humanities relevant to one or a combination of the following themes: US-Japan relations, problems common to industrialized and industrializing societies, and global issues. The Abe Fellowship program is conducted in cooperation with the Social Sciences Research Council (SSRC) and the American Council of Learned Societies (ACLS).

The annual Abe Fellowship retreat for new fellows, the Abe Colloquia, and informal "Brown Bag Lunch" discussions promote interaction and networking among fellows and other related experts. The CGP-SSRC Seminar Series brings together former fellows and other specialists. This year's Seminar Series included, "Remaking Transnationalism: Japan, Foreign Aid, and the Search for Global Solutions" and "Soft Power: National Assets in Japan and the United States."

To date, CGP has awarded 234 Abe Fellowships to individuals affiliated with Japanese and US universities and think tanks, as well as to individuals in the fields of journalism and law. The 16 individuals listed below represent the 2005-2006 fellows.

Grassroots Exchange

CGP provides funding for grassroots exchange and education projects to strengthen multifaceted networks between the people of Japan and the United States, thus enhancing mutual understanding and communication between citizens of both countries.

The Grassroots Exchange Program supports the exploration of common social issues through exchange of expertise and collaborative action among practitioners, researchers, and committed members of the general public in the United States and Japan. The Education Program supports activities that foster understanding and awareness of Japan in the United States and of the United States in Japan at the K-12 level. The US Nonprofit Leader's Visit to Japan Program provides support for experienced nonprofit professionals from the United States to travel to Japan in order to share expertise with the Japanese audience.

CGP jointly administers JOI with The Laurasian Institution.

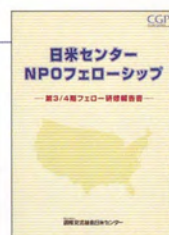

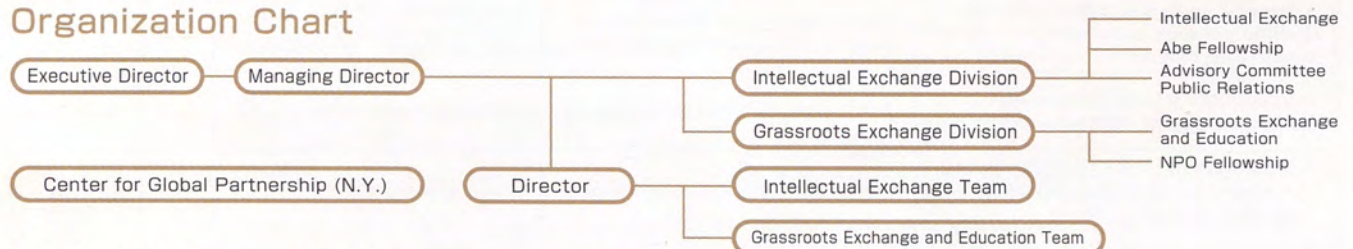

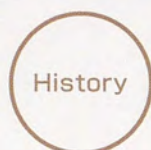
Mission
