Keynote: Advancing Mutual Understanding Through the Creative Industries 09:10-10:50 am

Japan and the United States share a common appreciation for the value of film, media, and the arts as "soft power." In its "Action Plan for New Capitalism 2024," the Government of Japan (GOJ) seeks to clarify the important role it plays in supporting creators and the content industry, which — if effective — can spark imaginations, foster curiosity, and promote understanding between people. Two prominent speakers from Japan, honored guests Mr. Shunichi Tokura and Mr. Hiroyasu Matsuoka will provide public and private-sector perspectives on Japan's efforts to promote the creative industries (the "contents industry" in Japan).

U.S. CULCON Vice Chair Dr. William Tsutsui will moderate the fireside discussion to follow using his research on Godzilla (now an Academy Award Winner) to guide thoughts on how creators can — and do—generate interest and bring people closer together through effective communication of cultural ideas and assets.

Panel: The Impacts of Digitization and A.I. on Information Access 10:55-11:45 am

This panel takes on the topic of the impact of digitization and A.I. on the spread of reliable information in the US-Japan binational community. What responsibilities do experts in higher education, in mass media industries, and in information-science technology have in shaping the current information landscape? How does one go about providing and sharing reliable information? How does the availability or lack thereof of digital resources change the study of Japan and the study of the United States? What does this portend for the binational partnership moving forward? Mr. Trevor Dawes will provide introductory comments, including background on the various discussions of the CULCON Information Access and Sharing Working Group on encouraging responsible digital transformation and resource sharing. Three expert panelists will then discuss methods and ethics for expanding reliable information access for students, scholars, and leaders in the U.S.-Japan partnership.
